The Annual General Meeting of NPSC CGHS Ltd., was held on Sunday, the 29th September, 2024 at 08.45 AM. As per the rules, the proceedings were video recorded. Only 30 members were present till 08.45 AM. As the quorum was not complete, it was adjourned to reassemble at 09.15 AM. Accordingly, the AGM reassembled at 09.15 AM without waiting for the quorum, and 6.3 members were present in the meeting and the meeting started at 09.30 AM.

The President intimated that, since the last AGM, Mrs Uma Sharma B 702, member, Gp Captain TB Srivastava, A 303, member, Mother of Mr. Ajay Gupta, D 403, Mother of Mrs Nilakshi Chatterjee C 503, Mother of Mrs. Shobha Tandon C 103, have left for heavenly abode.

As a mark of respect to the departed souls, the members observed one minute silence.

Point No 1 - Welcome Address by the President

The President welcomed all the members and expressed his gratitude to the members of the Managing Committee and Sub Committees, for the excellent work done during the tenure, other members of the Society for their contribution by giving suggestions for the betterment of the Society and for those members also who gave energy to the Managing Committee by their criticism.

He also appreciated the MC for good financial management. He intimated that when this MC took over, the Society had bank balance of only Rs 35 Lakhs and there was no FD and now at present the Society has FD of Rs 4.75 Crores and cash balance of Rs 8.5 Lakhs. The amount of Rs 3.30 Crores was received from the allotment of two flats and Rs 1 Crore 45 Thousand collected as Building Fund during the tenure of the MC is absolutely intact. Inspite of this, the MC has upgraded the ambience of the Society by installing grills, decorative lights and fountains and will continue to do so. All the members present appreciated the good work done by the Managing Committee.

Removal of Life-threatening Loose Grit

The condition of loose falling grit still existed. The MC advertised and sent proposals to a number of Contractors/Structure Engineers the response had been not very encouraging since they were not able to give the assessment of damages, time for repair and mainly the cost of the project.

As brought out by the President in the opening address, the next course of action would be decided by holding a GBM for this purpose.

Change of Generators as per NGT Orders

The Electrical Sub Committee had explored all the possibilities and finally recommended to buy the new generators. Dual Fuel Generators have high running and maintenance costs, RECD can not be put on the old generators. A fine of Rs 15,000/ per day per generator had been laid down by the Government agencies against the defaulters. Majority of the Societies in Dwarka either had purchased or in the process of procuring. The purchase had to be executed on Priority to avoid fines.

Change of lifts

The lifts in the Society were of 2003 vintage. Accordingly, OTIS had been requested to give technical feasibility report on the status of the Lifts. The spade work done by the Lift Sub Committee would be placed on record after getting the feasibility status report. The ARDs are functional and the old batteries have been replaced.

Court Cases

The status of the court cases of the society are as follows:

(a) N.P.S.C. CGHS Ltd. Vs. Mrs. Shashi Sood & Anr.

This case had been pending in courts for more than 15 years. At present it was pending before the Court of Delhi Cooperative Tribunal and was at the stage of arguments. As the defendants were willing to settle the matter out of the court, and pay the entire amount due along with interest, and in terms of the settlement they have paid an amount of **Rs.15,69,984/-.** Accordingly, this case has been **disposed of vide** court's order dated 21.11.2023.

(b) A.S. Enterprises Vs. N.P.S.C. CGHS Ltd.

This case was filed by the Electricity Contractor M/s AS Enterprises which had been pending for a long time. According to the Plaintiff, the society had owed an amount of over Rs.10 lakhs to it. Besides this, wrong documents had been filed on behalf of the Society by a previous Managing Committee. The matter had been settled with the Plaintiff vide Settlement Deed dated 21.12,2023 for

(c) Mr Raman Kumar Mehta Vs. NPSC CGHS Ltd.

This case had been filed by the erstwhile tenant of C-301 against the Society and the same was pending adjudication before Hon'ble Delhi High Court. The matter was argued in court, and the Hon'ble High Court was pleased to **dismiss** the Writ Petition filed by the Petitioner, Mr Raman Kumar Mehta vide its judgment dated 05.02.2024.

(d) Susheela Kaul Vs. NPSC CGHS Ltd. The case filed by the ex-member of the society, was pending adjudication before the Court of Registrar, Cooperative Societies, New Delhi. It was reserved for orders by the Court on 22.08.2023 and no judgment /order had been passed in the case till date.

The Secretary Report was also approved by a thumping majority.

After that the meeting came to an end and members points, if any, would be taken up in the next meeting.
